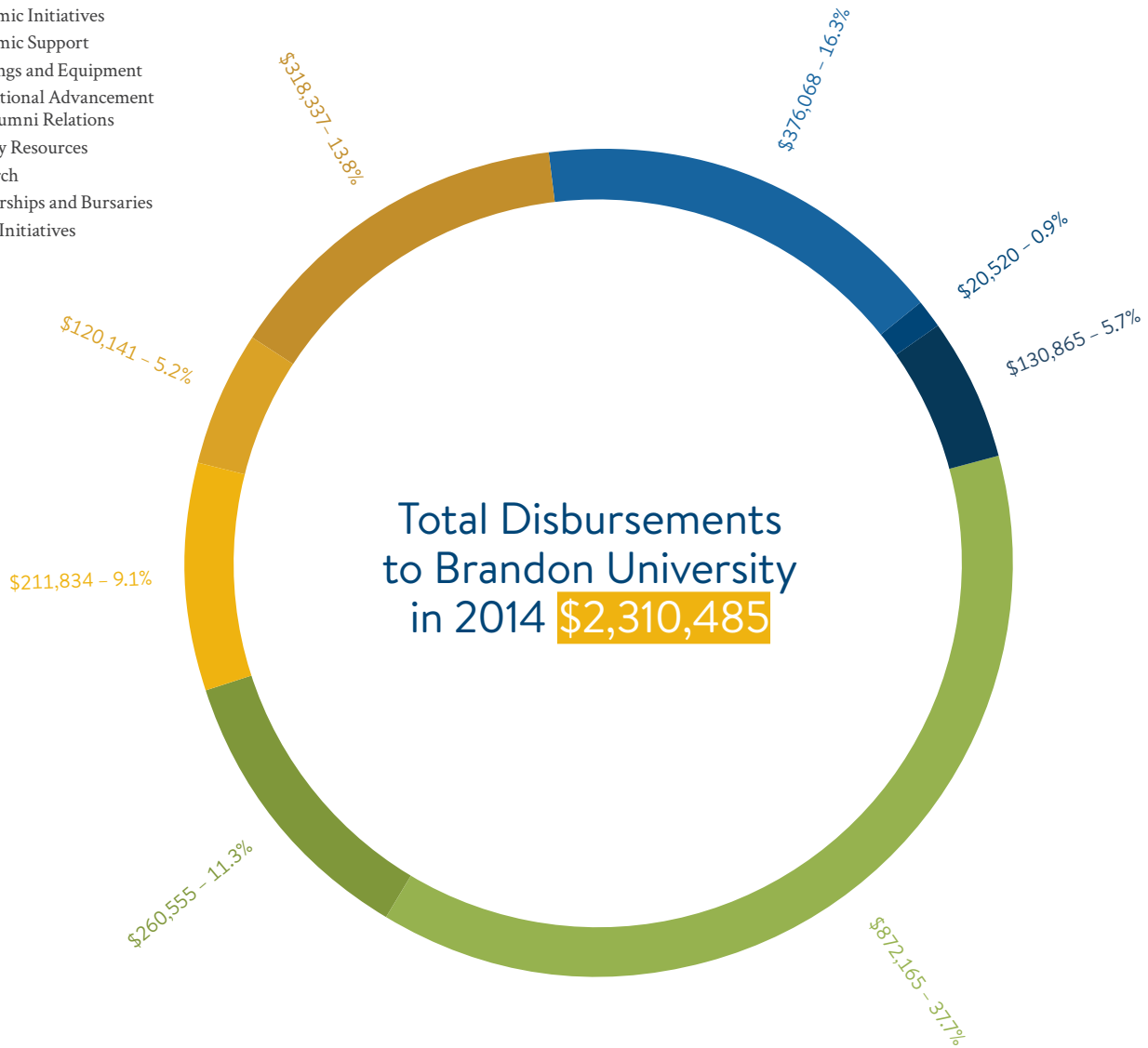

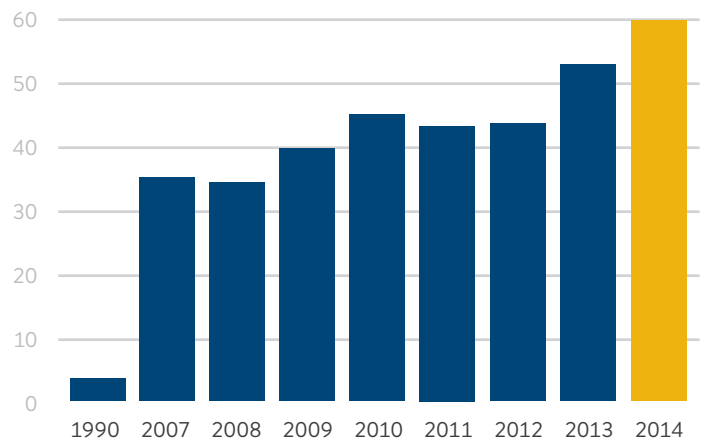
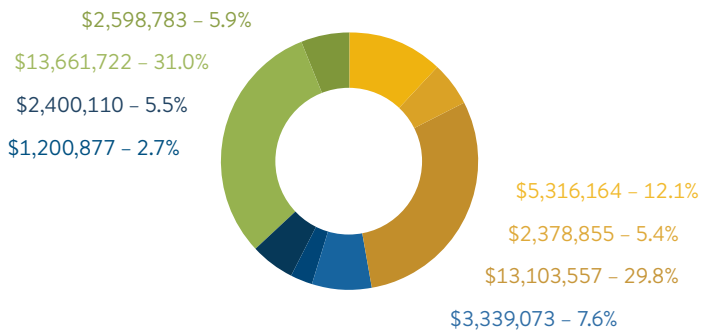

Total Disbursements to Brandon University Since 1980 \$43,999,141

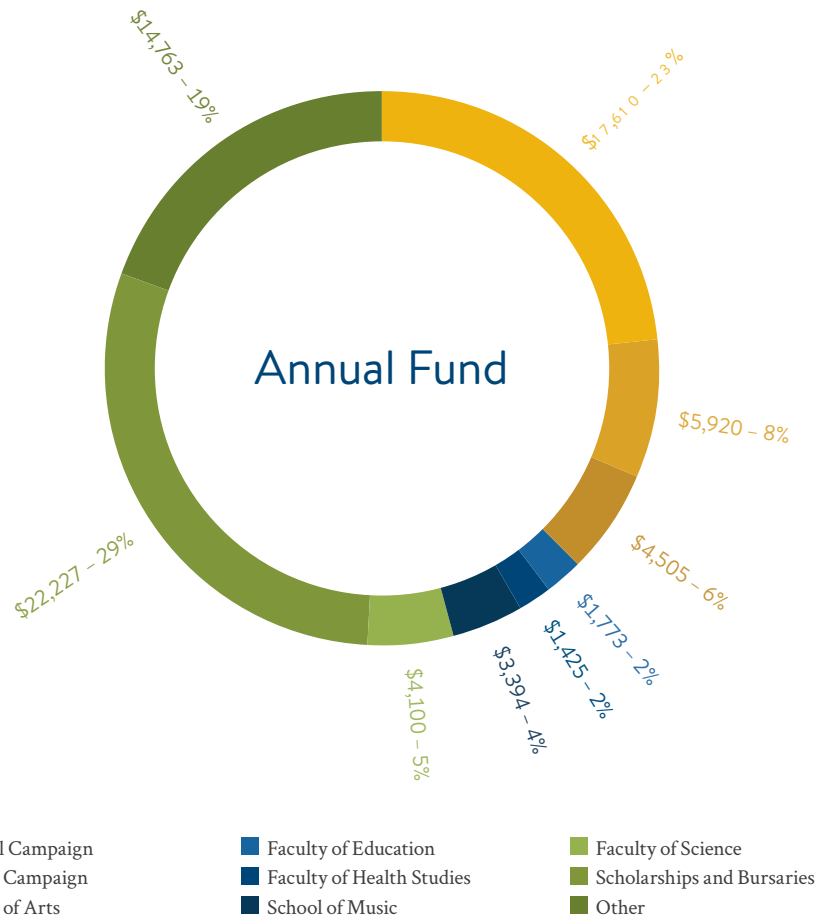


Net Assets Held by the Brandon University Foundation (in millions)

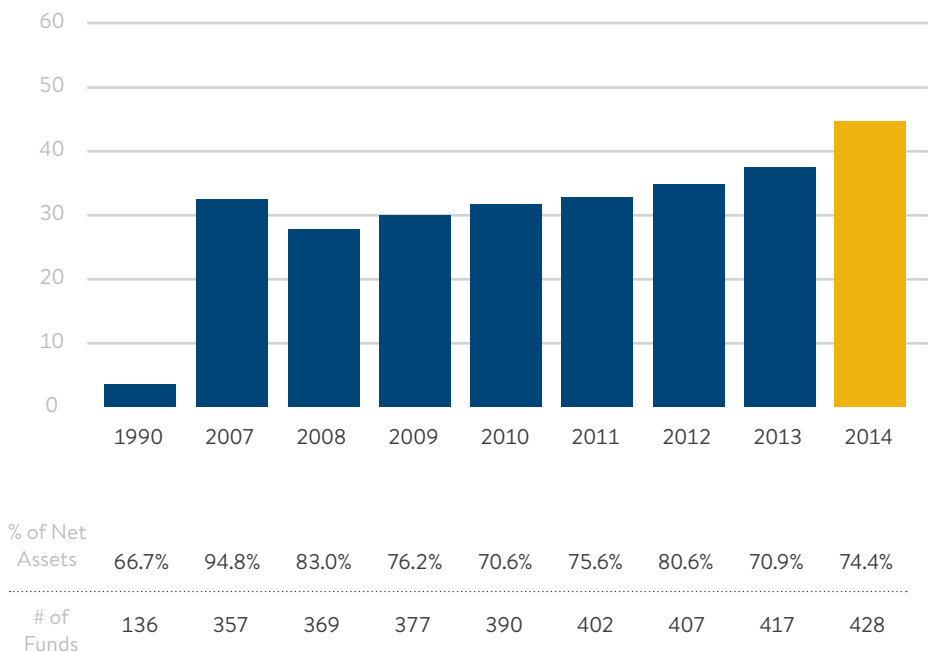

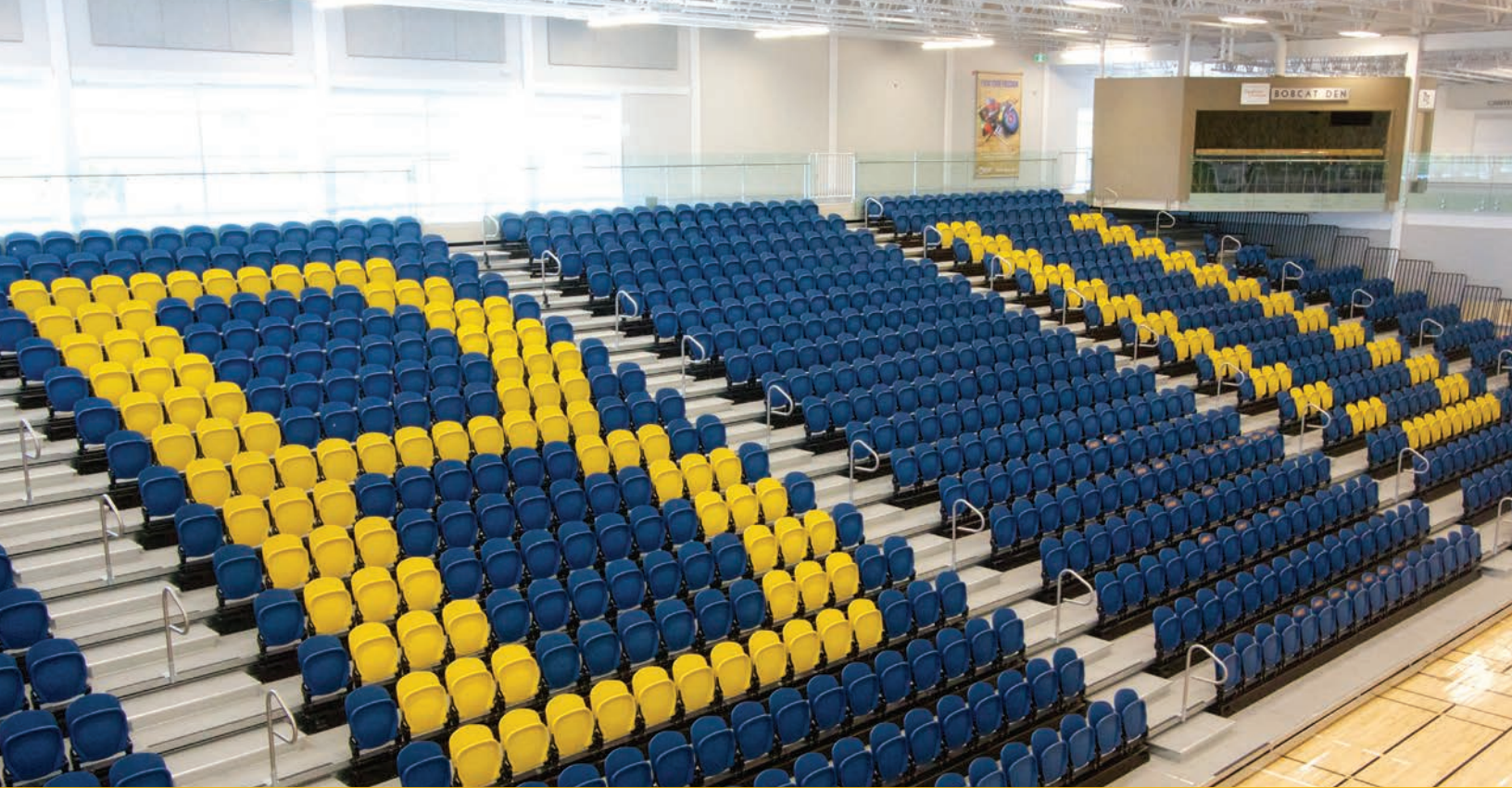

BU Surpasses Goal Set by Richardson Foundation

Richardson Foundation Partnership

In a show of their outstanding support for Brandon University's state-of-the-art Healthy Living Centre (HLC), the Winnipeg-based Richardson Foundation gave \$250,000 in 2014 toward the new facility, and pledged up to an additional \$250,000 in matching dollars for all HLC funds raised that same year. Through the generous support of our local community and partners, Brandon University is pleased to announce that we surpassed this matching fund goal in 2014, and that the total funds committed and leveraged by the Richardson Foundation now total well over \$750,000. In recognition of this partnership, the new gymnasium has been renamed the Richardson Gymnasium.

"Our firm and Foundation have a long history with and connection to Brandon University," says Hartley Richardson, President and Chief Executive Officer of James Richardson and Sons, Limited, and a trustee of the Richardson Foundation. "We are extremely pleased to be a part of BU's latest campaign and provide our support for this important community project."

Score a Seat Campaign

BU's success in surpassing this goal is largely thanks to the *Score a Seat* Campaign, a major community-based initiative launched in 2014 for the sale of over 1,000 spectator seats in the HLC. *Score a Seat* provides alumni, supporters and friends the opportunity to purchase one of the new spectator seats in the HLC, and affix their name or an inscription of their choosing on the seat for the next twenty years.

"Support for the HLC in 2014 through *Score a Seat*, with funds matched by the Richardson Foundation, offers an amazing opportunity to directly invest in the health and wellness of our Westman community," says Dr. Tom Breneman, BUILD Campaign Chair and local dentist. "The outstanding vision of the Richardson Foundation has helped us leverage this support, and we are delighted to have surpassed our goal."

To date, 200 seats have been sold in the Richardson Gymnasium, with all funds raised directly supporting the HLC. To purchase a seat of your own, contact the Advancement office at 204.727.7374.

HLC Donors Given VIP Treatment



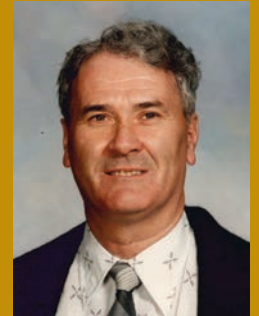

Local Family Establishes Award for Science Education

The family of David Keith Hunter, a Brandon College graduate and former Virden Collegiate science teacher, has established the David Keith Hunter Memorial Science-Education Scholarship-Bursary in memory of his commitment to science education in Westman. The family's gift is matched by the Manitoba Scholarship and Bursary Initiative (MSBI) to provide for an endowment valued at \$30,000. The scholarship-bursary will be awarded for academic merit and financial need to a BU Physics and/or Chemistry graduate entering the Bachelor of Education After Degree program at Brandon University. The family credits their past receipt of awards and scholarships while pursuing their education as the purpose behind "paying it forward" by establishing this new award.

BU Chancellor and former President establish award for Aboriginal students

During her tenure as President of Brandon University from 2009 – 2014, Dr. Deborah Poff contributed to an award fund for a scholarship-bursary for Aboriginal students, believing strongly in providing them with the supports needed to successfully complete their degrees. Mr. Michael Decter, Chancellor of BU, is recognizing her deep commitment to Aboriginal education and Brandon University by pledging \$50,000 over five years to this award. Thanks to the generosity of Dr. Poff and Mr. Decter, and the Manitoba Scholarship & Bursary Initiative, who have provided matching funds for a portion of these contributions, the Dr. Deborah Poff Aboriginal Student Scholarship-Bursary will provide an award of approximately \$3,000 annually to a full-time, undergraduate Aboriginal student when fully established. Contributions to this award fund have also been made by Dr. Alex Michalos and Mrs. Florence Brownridge.

Legacy Giving

Whether they take the form of a bequest, a gift of life insurance, securities, or other planned giving method, legacy gifts offer many advantages to both the donor, and the University. In addition to providing significant tax advantages to donors and/or their estates, these gifts make a significant impact on future generations of BU students and allow the University to plan ahead with confidence.

Those who have established a legacy gift are encouraged to advise us of their intentions. This allows us to thank donors now for their future gift, and can inspire others to also consider making a gift of this nature.

Mel and Ruth Turnbull Bequeath Half-a-Million Dollars to Brandon Students

A substantial gift from a Westman couple with deep ties to the area will assist future students in achieving their educational goals. Through a bequest, the late Mel and Ruth Turnbull from Hartney, Manitoba have established an endowment of \$261,589 in support of student awards at BU. They have also provided an equal amount in support of student awards at Assiniboine Community College.

Marion McGregor '63, a niece from Ontario, along with other family members, was on hand for the announcement in November 2014 and says, "Mel and Ruth never forgot what they had derived and what their families had derived" from higher education, beginning when Mel took music lessons at Brandon University (then Brandon College) at the age of five.

BU President and Vice-Chancellor, Dr. Gervan Fearon, says, "We are thankful for this gracious gift that will provide ongoing assistance to many individuals seeking access to post-secondary education for a better future. Indeed, this legacy from the Turnbills is about the future and shaping new possibilities for the next generation."

The *Mel and Ruth Turnbull Bursary* at Brandon University will support outstanding students with financial need. Each year, approximately \$12,000 will be shared, providing bursaries of up to full tuition for a number of BU students.

Mel Turnbull passed away in 1996, and Ruth in 2013. They will be fondly remembered through this very generous legacy gift.
