

First time requests for program extensions will be decided by the student's home Department/Program Advisory Committee. Second and subsequent extension requests will be decided by the Graduate Studies Committee, the decision of which is final. If the extension request is denied at the Department level, the student may [appeal](#) to the Graduate Studies Committee, the decision of which is final.

More than one extension period may be considered, but the total time for all extensions will not normally exceed **two years**.

A student who has exceeded the maximum program extension period or whose request for program extension has been denied may apply for readmission to the graduate program. If readmitted, the student's entire program will be reviewed, and a revised program and completion timeline will be developed.

DEADLINE: Completed form must be received in the Registrar's Office **two months** prior to the expiration of the program time limit.
