Frequently Asked Questions:

1. Why should teachers enter a Master of Education program?

A Master of Education degree program strengthens the process of continuous professional learning and remains the best way for teachers (in Manitoba) to receive classification increments. Teachers enrolled in a Master of Education program learn critical pedagogical and administrative skills, in addition to academic skills such as scholarly writing and research design.

2. What Graduate program options are available at Brandon University in the Faculty of Education?

Students have the following program options:

i) complete the first Master of Education degree: 36 credit hours.

For teachers in Manitoba: the Professional Certification Unit recognizes this for one classification increment.

ii) complete a second Master of Education degree at Brandon University, for 24 credit hours (this equates to a total of 60 credit hours between 1st & 2nd M.Ed. degrees at BU). Manitoba Teacher Certification recognizes the second M.Ed for one (1) additional increment. (*one's 1st Master of Education degree must be from Brandon University in order to be eligible for our 2nd Master of Education program*).

3. How much time do students have to complete the Master of Education program?

Students must complete all Master of Education program requirements within six (6) years of the commencement date of their 1st graduate course registration. (*Fall term start only*)

4. What areas of specialization are available in the Faculty of Education at Brandon University for the Master of Education program?

Students may choose from the following specialization areas: Inclusive Education, Curriculum and Pedagogy*, Educational Administration, or Guidance & Counselling*.

*the Curriculum and Pedagogy program for our 36-credit hour M.Ed. is not currently available for the 2026-27 year start, as it is only available to those identified within the OCN Community-Based Cohort.

*the Guidance & Counselling program is not available to International applicants at this time.

5. What does a typical course schedule look like in the Master of Education program?

While the delivery method may vary from one specialization to another, typically the courses take place as follows (all posted time slots on schedules are in "Central Time"):

- Regular Session (Fall=Term 1, Winter=Term 2): evenings during the week (or weekends, for Guidance & Counselling)
- Spring Session (Both Term): evenings during the week (or weekends, for Guidance & Counselling)
- Summer Session (July=Term 1, August=Term 2): e.g. Monday-Friday during the daytime.

6. Can students take courses through distance delivery?

The Master of Education program continues to increase its focus on alternative course delivery strategies, especially for off-campus students. For distance delivery, courses are offered using a combination of on-line (NET/NT1/NT2/NT3/NT4 = online/distance delivery). In addition, video-conferencing (Zoom or MS Teams) is widely used within our program.

While many courses are available on-line or by distance, some still require face-to-face instruction (A10 or A00), such as those in the Guidance & Counselling Master of Education program. In these cases, the required courses are generally scheduled during weekends, allowing off-campus students to more conveniently attend classes. Graduate courses offered during the Summer Session may also include daytime on-campus classes.

7. Are students required to write a thesis in the Master of Education program?

In the first Master of Education program, students are admitted initially into the course route, however once 15 credit hours (including the 2 core courses: 07:752, and 07:714) have been successfully completed, the student, in consultation with the department chair, may then begin the process to apply for consideration, into the Thesis route for the Master of Education program (*as per the approved Master of Education Thesis Protocol available on our website*)

8. What is required for Admission to the Master of Education Program?

There is a 2-step process for all applicants, which includes 2 applications as outlined below (and via our website).

The annual application and documents deadline(s) for our Master of Education program:

International applicants only:

December 15th: Central Admissions application & transcripts in by deadline.

January 15th: Master of Education application & documents in by deadline.

Domestic (Canadian) applicants only:

February 25th: Central Admissions application & transcripts in by deadline.

March 15th: Master of Education application & documents in by deadline.

The Brandon University Central Admissions Office charges an application fee during the 1st application submission:

- \$ 70.00 CDN\$ for Domestic (Canadian) applicants (*waived for BU graduates of 2023 or later*)
- \$140.00 CDN\$ for International applicants

When completing the secondary online application, for the Master of Education program (*after being cleared by Central Admissions*), you will also need to scan & upload all of the following documents:

- copy of your valid teaching certificate.
- letter from your employer on letterhead, verifying at least two years of teaching experience.
- original transcript indicating a grade point average of 3.0 or higher in the B.Ed. degree. (*For those that received their B.Ed. degree from Brandon University, this document will upload automatically*).
- Résumé or Curriculum Vitae (CV)
- YouTube Video (optional): if you would like to include a link to a private YouTube video that you have created to support your application, you may insert the URL in the section as is provided on the M.Ed. application.
- Statement of Interest and a Sample of Written Work (*see our website for directions*). These are 2 separate documents.

Master of Education Application Fee:

\$100.00 CDN\$. This is due at time of submitting your Master of Education online application and is non-refundable.

Confidential Letters of Reference:

Applicants will enter the full names, positions, and email addresses of their 2 referees (1 academic and 1 supervisory) while they are completing our online Master of Education application.

Once the Master of Education application is submitted online, our Graduate Studies office will then forward a confidential letter of reference form directly to each referee, for them to complete and return to our office via email by:

→ **January 15th** deadline: for International applicants only.

→ **March 15th** deadline: for Canadian applicants only.

9. Can students transfer previous course work into the Master of Education program?

Students may be eligible to transfer up to a maximum of 6 credit hours of “extra” graduate level course work from another university, providing the courses are current (within 6 years) and not at risk of becoming stale-date in the M.Ed. program, have not been used for credit in a previous program & will not be used in future for credit towards another program outside of Brandon University, are recognized for Brandon University graduate level course equivalency, and are approved for credit within the student’s program of study.

10. Can students, once enrolled in the Master of Education program, take graduate level courses from another university for credit towards their Master of Education degree at BU?

Yes, to a maximum of 6 credit hours, via a Letter of Permission (LOP), and in advance of registration with the delivering institution. Please refer to the BU website below for directions on the LOP process:
