DO NOT perform this procedure until you have been appropriately trained and authorized to do so.

Required Training

- WHMIS
- Use of buffer and wet vacuum

Knee pads for work on hands and knees

Potential Hazards

- Chemical Contact
- · Chemical Splashing
- Chemical vapors
- Slip and fall
- Sprains and strains from manual scrubbing or lifting

Pre-Operational Safety Checks

- Become knowledgeable of chemicals to be used by reading the suppliers labels and the MSDS.
- Inspect required personal protective equipment and replace if required.
- Respirators must be fit to each individual. Only use the respirator designated for you.
 Check to ensure that the cartridge is installed and is not expired. The proper cartridge
 is a P100 filter with multi-gas cartridge (will work for Organic vapors and
 Formaldehyde).
- If working alone, establish a communication plan in accordance with department requirements.
- Have a portable eyewash station on site of cleaning.

Prohibited Activities

Safe Work Procedure

1. Walk through the location and remove obstacles on the floor. Use safe lifting/moving

techniques.

- 2. Post wet floor signs and sign(s) "Do not enter. Caution: Chemical cleaning in progress."
- 3. Put on personal protective equipment.
- 4. Pour floor stripper in area slowly to minimize splashing. Cover entire surface.
- 5. Leave area with doors closed and locked (if possible) for one hour or longer depending on application.
- 6. Using power buffer, buff as much surface area as possible. Use extra caution around equipment.
- 7. For areas that require manual scrubbing, scrub "away" from the body as much as possible.
- 8. Pour grout cleaner slowly into area to minimize splashing.
- 9. Repeat steps 5-7 as necessary.
- 10. Use wet vacuum to pick-up remaining liquid. Store in WHMIS labeled container.
- 11. Keep areas closed for as long as possible. Remove signs at the end of the night shift. **CAUTION:**
 - 1) Avoid splashing.
 - 2) Wet surfaces are a slip and fall hazard

If an emergency situation occurs while conducting this task, or there is an equipment malfunction, shut the equipment off immediately and follow the lock out procedure listed below

REPORT ANY HAZARDOUS SITUATION TO YOUR INSTRUCTOR/SUPERVISOR IMMEDIATELY

Keep tools, machinery, and cords off the floor as much as possible to prevent trip
