## MOTION 009.JUNE18 SC Gatien/Ardelli

THAT Senate approve the revised Terms of Reference and award value for the Karl Popper Scholarship in Philosophy as follows:

To be awarded to a third or fourth year student proceeding to: a) a Four Year B.A. (Honours) Degree in Philosophy at Brandon University, or b) graduate studies in Philosophy in another university, or c) any program of a professional School/Faculty at Brandon or another University. To be eligible for the award, the student should have achieved the highest academic standing and no less than a B+ average in at least 6 credit hours of Philosophy taken from the following courses during his/her second and third years at Brandon University: 70:260 Philosophy of Science I; 70:352 Analytical Philosophy of History; 70:360 Symbolic Logic; 70:361 Theory of Knowledge; 70:363 Authors; and 70:369 Philosophy of Science II.

#### Award Value: Approx. \$2,155.00

Established in honour of the late Karl Popper's problem-solving and critical approach to philosophy, this scholarship is awarded upon the recommendation of the Philosophy Department to an outstanding 3<sup>rd</sup> or 4<sup>th</sup> year Philosophy student who has taken 70:258 Predicate Logic, or its equivalent. Additionally, preference will be given to the student who has taken: (i) one of 70:253 Plato and the Presocratics, 70:268 The British Empiricists, 70:269 The Continental Rationalists, and (ii) one of 70:261 Theory of Knowledge, 70:265 Introduction to Political Philosophy, and 70:369 Philosophy of Science; or their equivalents. This award may not be divided. Award Value: Use income allocation, approximately \$1,150.00\*

# 5.7 Report from the Vice-President (Academic & Provost) (Sen. Serfaty)

Senator Serfaty reported on the following:

• The Provincial department of Education and Training is currently undertaking review of three programs that affect BU. First is the MSBI, a fund that has been in operation in MB for a number of years but was drastically changed last year. The government is now reviewing the new version and has requested various forms of input from all PSE institutions. The second is Access, a provincial program that has provided funding for accessibility to PSE by students who are disadvantaged in a variety of ways (financial, geographical, ethnic, among others). BU has never been part of this program, but the government is currently reviewing it with institutional assistance with the view to including all PSE institutions in the future. The third initiative relates to Campus Manitoba, a consortium of all PSE institutions that both PSE institutions and government believe needs reforming. A meeting of VPs Academic will be taking place in July/August to discuss options for the future viability of this project.

- After a review of Campus Manitoba last year, the Provincial government and the Manitoba postsecondary institutions are working on establishing the role/function of the program.
- The government is looking at ways to make the Access Manitoba program more inclusive.
- Brandon University now has three Canada Research Chairs: Rachel Herron Geography, Jonathan Allan – Gender and Women's Studies, and Sara Plosker – Mathematics and Computer Science. There will be a call for applications for a fourth chair.
- 5.8 President's Report (Dr. Robinson)

Dr. Robinson reported on the following:

- He attended an alumni event in Vancouver where he was able to meet individually with potential and current donors.
- He attended Convocation on June 1<sup>st</sup> and the All Nations Pow Wow on June 2<sup>nd</sup>.
- He was invited to be part of the platform party at his son's graduation from University of Ontario Institute of Technology.
- He and Senator Lamont traveled to Vancouver to attend the Canadian Association of University Business Officers (CAUBO) conference.
- Representatives from BU had the opportunity to meet with the Provincial Government to share the BU Master Plan and answer any questions the government had.
