3.3.6 Report from the Brandon University Students' Union (BUSU) President (Sen. Akintola)

Senator Akintola reported on the following:

- BUSU celebrated its 50th Anniversary on December 4, 2019. It was a very successful
 event with a high attendance. There were representatives from the Province of
 Manitoba, the City of Brandon, and the BU Alumni Association who brought
 greetings. Several staff and faculty members also attended. BUSU hosted a free lunch
 for the students and over 300 students attended the event.
- BUSU has rebranded their logo to show the core areas of business: Events, Advocacy, Services, and Engagement.
- BUSU has created a social media strategy to engage students. They are pleased to report an increase of about 300% in student engagement with BUSU since it was launched.
- BUSU has formed a partnership with Fusion Credit Union and the library to have an Energy Pod to be placed in the library. This is an initiative by BUSU to give students the opportunity to have a power nap if need when in the library.
- BUSU has created a new service for all students and staff beginning in January 2020. In partnership with the HLC, BUSU will be offering a free fitness class for students, faculty and staff for the month of January.
- BUSU hosted the Canadian Federation of Students Provincial Executive meeting on November 21, 2019.
- BUSU now has its Food Bank services extended to Student Services, Residence, Ancillary Services, and the IPC. This is part of BUSU's food security initiative on campus to enable students to get food hampers in these areas.

- Lots of research work was undertaken during the term, including several recent book publications: Reinhold Kramer's "Are We Postmodern Yet, and Were We Ever?" through Palgrave Macmillan, as well as Jonathan Allan's "Men, Masculinities, and Popular Romance" through Routledge.
- Faculty members have engaged in research affecting the community: Dr. Corinne
 Mason testified as an expert before the Manitoba Human Rights Commission in the
 matter of birth certificates and gender-neutral designations (see the news item on the
 BU website).
- Five students from Lisa Wood's Printmaking 1 in Visual and Aboriginal Arts are showing their work currently at the Martha Street Studio in Winnipeg (see BU news item on webpage).
- On January 1, 2020, Dr. Rachel Elliott will be starting a 2.5 year term in Philosophy.

- December final exam period is almost over. This is the first roll-out of the new
 University Examinations Policy, and overall, it has gone smoothly. Useful feedback
 has been received from a few instructors. All feedback based on instructors'
 experiences is welcome. Adjustments to the forms and Examinations Handbook will
 be made before the April exam period based on all information submitted.
- The December 1 admissions report will be finalized before the end of the week; staff changes in the Research Analyst position have delayed production of this report. Detailed information will be provided at January's Senate meeting.
- Adoption of an ERP will provide an opportunity to update and review many academic regulations and processes (academic performance assessment, continuing education framework, defining "active" graduate students, etc.); a number of these items will be brought to Senate for discussion beginning in the New Year.

3.3.9. Report from the Vice-President (Academic & Provost) (Sen. Robinson)

Senator Robinson reported on the following:

- In his current role as Acting Dean of Graduate Studies, he attended a recent event with graduate students and their families. In addition to music, there were videos where the students reported on what they liked about attending Brandon University.
- There is a committee reviewing the University's Policy on Academic Dishonesty and Misconduct. They have received feedback from a number of groups including faculty councils. This feedback has been very constructive and helpful. The committee has also

- accessed legal advice on some of the questions raised during these consultations. At this time, the document will not be ready to come forward to Senate and become part of the 2020-2021 calendar, but work will be ongoing.
- All of the short listed candidates for the CIO position have been on campus for interviews, and his office hopes to make a final decision soon.
- There have been four candidates short-listed for the Dean of Arts position. The selection committee will be scheduling interviews in January 2020.

3.3.10 **Report from the President** (Dr. Docherty)

Dr. Docherty reported on the following:

- He recently attended the Speech from the Throne. There was not a lot of comment regarding Post-Secondary institutions; however, there was mention of private investment in infrastructure needs.
- He, along with Presidents from other institutions, met with Ralph Eichler, Minister of Economic Development and Training.
- On November 27th, he met with second year students who had achieved a 4.0 GPA or higher and were inducted into the President's Honour Society on the basis of their performance in their first year. This gave students the opportunity to meet and interact with students from other faculties and to engage with him and the Deans. This is something that he would like to see continue a couple of times per term with the goal of having these student become peer mentors in the future as the initiative matures.
- The President's Circle recently held an event at the Art Gallery of Southwestern Manitoba. The President's Circle consists of individuals who make financial donations to the University. At the event, art works produced by Brandon University students were on display. The current curator, Alyssa Fearon, is a BU graduate, and she was able to explain how the donors' financial support to scholarships and bursaries help BU students.
- He reported that Ms. Karen MacDonald will be leaving BU in January, and Ms. Kristen Fisher will take on the role of Acting Chief Human Resources Officer.
- The agenda for the January Senate meeting will include a discussion on the Strategic Plan.
