4.5.6. Report from the Brandon University Students' Union (BUSU) President (Sen. Adeleye)

Senator Adeleye reported on the following:

- BUSU is working to build the trust of the students that was lost due to the election and court case that occurred during the summer.
- BUSU has rebranded its logo to focus on student representation, advocacy, events, services, and engagement.
- BUSU launched a new social media page called BUSU Connect in August to connect students to resources they need & assist in-coming and potential students to navigate these unprecedented times by answering questions and directing them to resources both in the university and community that would best serve them.
- BUSU advocated for a tuition decrease for students in September and although it was not approved, they were able to come to an understanding with the University.
- BUSU advocated for better health insurance since international students not currently in Canada had to still pay for health insurance. Discussions are continuing.
- The union had a successful fall orientation including a scavenger hunt event called The Amazing Race where students got prizes for participating and winning.
 - o COVID 19 guidelines were followed.
- The union has held multiple events that have largely been well received with some more successful than others. Examples including the following:
 - o Paint Night to help students relieve stress;
 - Trivia Game Night;
 - Halloween Food Drive to secure food for the food bank;
 - Netflix party where students could select from a list of movies and watch online with friends to help build community during these trying times.
- BUSU now has revamped its Food Bank services to better serve students subsequent to vandalism in October. They have set up an agreement with Student Services to extend service within that space. This is part of a food security initiative on campus to enable students to get food hampers in multiple places.
- BUSU foodbank will be up and running on November 19th as it was paused to restrategize on how students can receive the items while following COVID 19 guidelines and still maintaining the edibility of the food during the upcoming winter.

- BUSU recently partnered with Places 4 Students to provide an online collection of numerous housing options for students.
- BUSU just finished its hiring process for directors and was able to fill many positions.
- BUSU continues to advocate for students during this pandemic both academically and otherwise.
- BUSU is planning its annual holiday supper scheduled for the 16th. Quite a few students have registered so they are very excited about having a virtual meeting.
- Planning has begun for Snowientation in January.

4.5.8. Reports from the Members of Deans' Council

Arts - Senator Robson

Senator Robson reported on the following:

- The faculty members in Arts are looking forward to the holiday break as they have found this last term very challenging.
- Linda Tame, a Bachelor of Fine Arts student, has her final thesis presentation online, and it can be viewed virtually on the Glen P. Sutherland Gallery web site.
- A Master of Rural Development graduate, Adams Abdul Salam, has been elected to parliament in Ghana. He credits part of his success to his education at Brandon University in the Rural Development program.
- Dr. Chris Schneider, Department of Sociology, has been recognized with an
 international award from one of the world's largest academic publishers. He was
 the recipient of a 2020 Emerald Literati Outstanding Author Contribution
 Award
- The Faculty of Arts has recently added an Anthropology course to the Winter 2021 schedule: Anthropology of Global Public Health. Students will study the COVID-19 pandemic while living through it. They will be looking at organizations, governments, and agencies working worldwide and also assessing and exploring these groups' efforts to deal with COVID and stop its spread.

Science - Senator Ardelli

Senator Ardelli reported on the following:

- Dr. Nancy Newall (Psychology) received \$8,420.00 from the University of Manitoba for their research project entitled "Improving the Social Inclusion of Vulnerable Older Adults in Winnipeg".
- Dr. Hamid Mumin (Geology) received \$9,300.00 from Hudbay Minerals Inc., Manitoba Business Unit for their research project entitled "Nature of Gold in the 1901 Deposit, Snow Lake, Manitoba".
- On 16 December 2020, there will be a very big announcement. One of the embargoed items will be revealed.
- Science is about to receive a very unique piece of equipment called the Anatomage Table. BU will be the 5th university in Canada to own one of these. The Anatomage Table is the most technologically advanced anatomy visualization system on the market in the world. It is described as a game changer in student learning.
- Dr. Ardelli serves as the NSERC Leader for Brandon University and has attended a few NSERC Leaders meetings over the past year. On December 2-4th, she attended the Joint Annual SSHRC-NSERC Leaders Meeting with 142 participants. Some session highlights include the following:

- PromoScience will be developing a campaign to deal with vaccine hesitancy around COVID and also promoting the importance of research to society;
- Women are much more affected by the pandemic the road to achievement was not made easier because they are women;
- How to preserve a whole generation of researchers that could be lost due to hiring freezes, northern research impacted, lack of data collection, postdoctoral positions impacted – there is a cascading impact;
- What are the barriers that are pushing equity seeking groups out of research and how does the scholarly community protect those being most affected by the pandemic;
- After more than 20 years, they are finally raising the value of an NSERC USRA from \$4500 to \$6000 with a total value of around \$7500;
- There was an amazing session on anti-black racism and discrimination in research systems.

Education – Senator Duncan

Senator Duncan had no report at this time.

Health Studies - Senator Ross

Senator Ross reported on the following:

 She expressed her gratefulness for the ingenuity and tenacity of Health Studies students, faculty, and staff. Students have made it through the term and their clinical placements, staying on track for graduation.

Music - Senator Gatien

Senator Gatien reported on the following:

- The Alumni pro series was successful.
- The School is planning a virtual open house for prospective students in mid-January.
- Graduate students presented their research in a recent Out-of-Bounds Lecture. This was a highly successful, well attended event.
- The School has been busy with students recording auditions, recitals and juries, faculty recording/rehearsing concerts
 - There are many uplifting examples of the ingenuity, determination, and collegiality of students, staff, and faculty in navigating our first semester of pandemic teaching & learning.

Dean of Students - Senator Gross

Senator Gross reported on the following:

- Marsha Harris made and distributed 200 "Exam Kits" to residence students and students studying in the library.
- Katie has worked with the faculty from Gender and Women's Studies to create a COVID-19 Relief Fund for their major and minor students.
- There are still 14 students enrolled in the Al and Bee Wagner Transition program. Deidre Gregory is doing a fantastic job.
- The Office of International Activities hosted two virtual open houses on December 5th and 6th for prospective students.
- The Recruitment and Retention team is busy planning Early Alert and Orientation for the winter term.
- Thanks to BUSU for re-engaging their food security program.

CIO - Senator Sucha

Senator Sucha reported on the following:

COVID Response:

• The Library is operating in limited capacity and as essential service in line with public health orders.

Strategic Work:

- Library & IT Services issued BU's response, in collaboration with Research Office and Associate VP Research, to NDRIO (New Digital Research Infrastructure Organization) calls for white papers and documentation to inform their response to addressing national needs.
- Network and Operations investigated and reported on wireless performance in residence; results show that performance has improved from past years, but there is room for additional improvement as well. This was brought forward to Ancillary Services, and the unit agreed on investment in network infrastructure improvements in support of academic work and connected lifestyles. We anticipate that this will be an expectation for students living on campus beyond the pandemic.
- The Shared Chief Information Security Officer, Gerrit Bos, is onboard he is based in Winnipeg and will also support University of Winnipeg and Université de Saint-Boniface. He will commence cybersecurity assessment for each of the three institutions through January and February.
- Building off successful transition to virtual delivery for Orange Shirt Day, Library
 is collaborating with IPC and Organizational Learning in delivery of a new
 program: Speaking Our Truth Book Club. The activity will take place over a series
 of weeks and will be facilitated by a Knowledge Keeper. Registration numbers
 show positive interest.

Registrar - Ms. McDaniel

Ms. McDaniel reported on the following:

- The CampusNexus ERP implementation is ongoing
 - o "Spin o" data import has been completed, and data validation will begin shortly; this is the first test data import of several that will help the project team configure the system appropriately for Brandon University's historical data and go-forward plans.
 - The project team is currently working very hard on individual course configuration, including prerequisites and course equivalencies.
- The deadline for students to request Pass/No Credit grade conversion for Fall 2020 courses is January 20, 2021.
 - o Reminder that grade conversion is not appropriate for all students:
 - Health Studies has issued a letter to their students explaining how Pass/No Credit grading can and cannot apply to students in their programs;
 - Business and Economics are not permitting Pass grades to count as satisfying minimum specific grade requirements for prerequisite and graduation requirements;
 - Science departments are still discussing whether Pass grades will or will not satisfy minimum specific grade requirements;
 - Education has confirmed that Pass grades will satisfy teachable subject grade requirements.
- The first admission report for the 2021 admission cycle was issued December 1, and application numbers are down quite significantly relative to the same point last year; this is not unexpected given the current state of the ongoing pandemic and associated uncertainty.

- o Domestic application numbers are relatively stable; international applicants account for all of the decline in applications received.
- o It is anticipated that international numbers will pick up as the months continue and more is known about next year's programming at BU and the state of the pandemic in Canada.

4.5.9. Report from the Vice-President (Academic & Provost)

Senator Robinson reported on the following:

- There are 49 students in the Co-Operative Education Program. Of these students, 29 are new and 20 are continuing. These students represent eleven different degree programs. There are eleven students in each of Computer Science and Psychology.
- The first Co-Op student is on track to graduate in May.

4.5.10. Report from the President

Dr. Docherty reported on the following:

- There will be a second joint meeting of the Board of Governors and Senate.
 - Feedback from the last meeting was positive.
- The call for Chancellor has now been sent out and the recommendation will be presented to Senate by the Senate Executive in February 2021.
- The two searches for the AVP People and Talent and the VP Academic & Provost are both moving forward.
 - One challenge faced by the committees is candidates removing their applications from consideration due to not wanting to move during the pandemic.
- Advancement's annual fund raising has been very successful with many donors designating funds to student emergency support.
- The University will be holding a baking exchange to help bring back some spirit within the BU faculty and staff community.
- He congratulated everyone on Senate on making it through the term.
