- The current contract with Follett will expire in two years.
- It was suggested that Senator Robinson and Senator Gross work together to form this ad-hoc committee and that its membership should include but not be limited to the following: graduate and undergraduate students, instructors who have had issues and others who have not had issues with receiving books from the bookstore, instructors from both large classes and smaller classes.

# 4.4.3. 2021-22 Academic Program Delivery Planning (Sen. Robinson)

There was discussion regarding course delivery for this coming fall, including the following points:

- Senator Gross gave a short synopsis of the result of a student survey undertaken recently to assess student experiences related to remote learning and preferences for next year.
- British Columbia has announced that post-secondary students should return to oncampus studies in the fall.
- There will be a meeting next week of Manitoba post-secondary presidents, the Minister of Education, and Public Health to discuss the direction that the government is considering related to Fall 2021 post-secondary classes.
- The decision regarding Fall 2021 course delivery needs to be made sooner rather than later so that students, faculty, and staff can plan appropriately.
- Resistance to blended course delivery was expressed by some.
- At this time, Manitoba Public Health is suggesting that physical distancing will continue into the fall; BU does not have sufficient space in many classrooms to accommodate current physical distancing regulations.
- There were questions about whether international and out-of-province students will be eligible to receive COVID-19 vaccination once in Manitoba.

Senator Rourke was absent with regrets, but she supplied the following written report regarding the Board meeting of January 23, 2021:

- \$283K was raised for the annual fund (goal was \$300K) with strong support from alumni and community.
- Foundations Committee Updates on the foundation's investments were discussed as well as strategies moving forward.
- Revised Terms of Reference changed for International Undergraduate Student Scholarship the requirement that the students must apply for the scholarship was removed as the University was building too much money in the fund.

#### Arts Faculty – Sen. Robson

• Senator Robson was absent with regrets.

# Science Faculty – Sen. Ardelli

- The faculty in Science have held several discussions regarding what the Fall term will look like.
- They have a number of initiatives underway to welcome student back on campus.
- They are renovating spaces for new faculty members and Honours thesis students, as well as a multidisciplinary clubroom for students.

#### School of Music - Sen. Gatien

- Faculty searches are currently underway.
- Student recitals are being rehearsed and recorded per pandemic protocols.
- Faculty remain busy:
  - Two pro series concerts coming up (Cathy Wood on April 6 and Nancy Hennen on April 20).
  - Caroline Ehman just gave a brilliant talk on the notions of maternity in modern opera as the last lecture in our Out of Bounds Lecture Series
- Former student, current doctoral candidate at the University of Utah, Daniel Tselyakov performed last Tuesday night in a pro series concert. On our two platforms, we had over 1,300 people attend the livestream.
- Music Enrichment program has about 60 students registered; it offers enhanced
  opportunities for Conservatory scholarship recipients, provides teaching experience
  for recommended BU students and a few alumni, and will feature some exciting
  online group classes delivered by our faculty.

# Education Faculty – Sen. Duncan

- At the last EFC, there were presentations of some of the work that students are doing.
  - These presentations were so exceptional, Education will be developing a web page dedicated to showcasing student work.
- Education is currently undertaking four faculty searches, and the committees have shortlisted for three of the positions.

# Health Studies - Sen. Ross

• Congratulations to Brandon University Bachelor of Nursing students, Hannah Friesen and Jennifer Harrison, for completing the research for PMH Palliative Care team's "Death Education for Children and Young People in Public Schools". This article was published in the International Journal of Palliative Nursing (IJPN). Melissa Peters, Regional Palliative Care Coordinator, was the student mentor for the project. Hannah Friesen and Melissa Peters also presented this article at the International Online Summit on Palliative Care and Medicine on December 17, 2020. The Palliative Care team has also accepted an offer to become article reviewers for the IJPN.

• Darlene Paquette was appointed to the Brandon Urban Aboriginal Peoples Council (BUAPC) as one of two citizen-at-large appointments. (Brandon Sun March 4, 2021)

#### Dean of Students - Sen. Gross

- Student Services is currently searching for a part-time Academic Advisor and a Director of Recruitment and Retention (one-year term).
- Four outbound and two inbound students are scheduled to participate in the National Student Exchange program. Thanks to David Rowland for his work.
- Activities and workshops are being held for celebrating Indigenous Excellence Month. Thanks to Michelle Bessette, Deidre Gregory, and Chris Lagimodiere.

#### CIO - Sen. Sucha

- Operations continue per BU's Phase Blue protocols and government health orders. The Library and IT are prepared to scale operations for the Fall term in line with the University's plan and approach.
- The Library continues with its deselection and shifting work to right-size its collection and physical spaces. Creation of an accessibility corridor in the second level stacks is underway, in line with accessibility legislation. Additional space is being opened in the Solarium workspace at the south end, in keeping with original space design and allowing for greater access to electrical outlets and natural light sources. Later in the spring/summer, we will aim to create greater access to the Curve Gallery at the north-west area of the second floor. Deselection lists will be posted campus-wide in line with Senate Policy.
- The Senate Library and Archives Committee will convene on March 19 to discuss by-laws review and preliminary findings of the Budget Allocation Implementation Project. Next steps through spring/summer will include Committee feedback to the updated Collection Development Policy, which is then brought to Senate for approval.
- The Library developed a virtual display of the First Nation Communities READ Program and provided this material to IPC to reference in Indigenous Excellence celebrations.
- The ERP Project launched its new website and held a Town Hall event on March 2, explaining the first roll out of the ERP system focused on Student Lifecycle.
- Working with Shared CISO, we have submitted our cybersecurity assessment which is being analyzed in conjunction with assessment of the other partner universities, with report-back in early April. In light of ransomware attacks that have impacted some K-12 school boards in the province in various ways, and a recent and severe cyberattack at Lakehead University, the strategic work of the Shared CISO becomes increasingly important in helping us to manage cybersecurity risk.
- On tactical IT security, Microsoft released an emergency patch week of March 8, to address unexpected vulnerabilities in on-premise Exchange email Server. We applied this patch same day as we were notified. BU has plans to update our Exchange environment, migrating it from a physical server to the Microsoft 365 cloud service. This will reduce the need for BU's NetOps to apply security patches and mitigations directly.
- With Research Support Funds, the Library and Archives are proceeding with digitization of: Manitoba Pool Elevator Pool Fonds; the Brandon Sun; microfilming and digitization where copyright clearance obtained for Indigenous Community newspapers, video materials from the Brandon University fonds and the Westman Coalition on Equality Rights in the Canadian Constitution fonds; audio materials from the Westman Oral History collection and the Brandon University 75th Anniversary concert.

#### Registrar - Ms. McDaniel

• Admission applications are down about 6% overall compared to the same point last year

- o Domestic applications are stable, but international applications, particularly those from Nigeria, are down significantly
- The Convocation planning team continues to work diligently to determine what this year's Spring Convocation will look like
  - A survey is out to students to gauge their desire and ability to participate in limited in-person elements as part of the Convocation celebration
  - There will be a robust virtual offering given that many graduating students are not in Brandon and would be unable to participate in any inperson activities
- ERP implementation work is ongoing
  - The project is hiring a new team member to assist specifically with configuring Registrar's Office elements and processes
  - Detailed curriculum configuration will begin shortly, so the project team will be reaching out to individual academic areas as needed over the coming months

# 4.4.11. Report from the Vice-President (Academic & Provost) (Sen. Robinson)

Sen. Robinson reported on the following:

- On March 4<sup>th</sup> he attended the virtual book launch of Beverly Hicks' book, *Politics, Personalities and Persistence One Hundred Years of Psychiatric Nursing Education in Manitoba*.
- He noted that Dr. Docherty will be the guest speaker at the Chamber of Commerce luncheon on March 18<sup>th</sup> where there will be an announcement regarding Brandon University's Co-Operative Education program.

# 4.4.12. Report from the President (Dr. Docherty)

Dr. Docherty reported on the following:

- A draft of the University's strategic plan will be going to the next Board meeting. The plan will focus on value added and what BU adds to the system of education.
- The motions passed by Senate at the January meeting recommending that the President pursue changes to the University Act regarding the composition of both the Board and Senate. The recommendation was to have one seat on both committees be designated reserved for an Indigenous member.
- The budget will be going to the Board this week.
- On Friday, he attended a workshop hosted by the McConnell Foundation based in Montreal. The foundation is working with 11 universities in Canada, one of which is BU. The theme of the workshop is "Building Back Better": how do we build back from COVID in terms of community engagement and social impact? There were individuals from many different areas including but not limited to the Chamber, Labour Council, the Mayor, and social service agencies.
- Once physical distancing rules allow for more individuals to gather, an event will be planned to raise a number of Indigenous flags on the new flag poles.
