Some users are also having trouble losing saved catalogue search results in this case, they should contact their faculty's liaison librarian for assistance and workarounds with their searches.
- This week, ITS is responding to some global security vulnerabilities that put our network at risk. The planned network outage this evening will allow for necessary patching to mitigate the vulnerability.
- ITS is also responding to an unanticipated database issue, unrelated to security vulnerabilities. In cases like this, we do aim to provide campus with clear and open updates on the problem, impacts, and time to resolve.
- ITS is preparing for self-phishing campaigns for both employees and students in January, to instill cybersecurity awareness.
