3.4.6. Report from the Brandon University Students' Union (BUSU) President (Sen. Olufunke Adeleye)

Senator Adeleye reported on the following:

- BUSU Holiday Dinner will take place Dec 20<sup>th</sup> 5pm to 7pm at the Mingling area/Baileys Café. This year, the theme will be multicultural and highlight Christmas foods from other cultures from BU's international student body.
- BUSU has created a Black Students Director as part of the Board of Directors and the Black Students Alliance as a BUSU collective. This came after Black students communicated the need for a space for Black students on campus.
- BUSU had a joint meeting with the BU President's Executive Council, the
  University Registrar, and the Dean of Students on November 30<sup>th</sup>, 2022. There was
  good discussion regarding students and their needs, and a follow-up meeting is
  scheduled in January 2023.
- Monthly meetings with the University President continue.
- Bi-weekly meetings with the Dean of Students continue.
- Senator Adeleye attended the BU SAAG (Sexual Assault Advisory Group) first meeting on November 22nd, 2022.

- BUSU met with Minister Reyes to advocate for international students' healthcare, talk about BU students' tuition fees, and discuss immigration pathways for international students. The minister committed to meeting with BUSU in person for more robust conversations.
- The soft launch of the Café was held today, December 13, 2023, but the grand opening will be in January.

#### 3.4.7. Report from the Board of Governors Representative (Senator Bach)

#### Senator Bach reported on the following:

- The Board of Governors met on Saturday, November 26th, in the Louis Riel Room. The meeting began with a wonderful Indigenous sculpture presentation by our colleague, Kevin McKenzie. Time permitting, Senator Bach would like the Senate to consider inviting Professor McKenzie to share that same presentation with Senate at a future meeting. Senator Bach found the presentation profoundly moving. K. McKenzie spoke of the inspirations for this remarkable work of art and referred to the sculpture as a dedication to Truth and Reconciliation. He felt the sculpture would serve as a kind of healing process, a place to gather for discussion. The sculpture would serve as a beacon to look forward, not backward, and at 24 feet and 5,000 pounds, it certainly draws one's eye. Chancellor McCallum indicated that, through this sculpture, Kevin McKenzie brought Indigenous knowledge to art.
- The Board approved the endowment earnings disbursement rate of 4.5% as recommended by the Brandon University Foundation.
- Quintin Pearce was elected to the Vice-President, Research and Graduate Studies Selection Committee.
- Kristal Bayes-McDonald was elected to the position of Secretary of the Board of Governors.
- Kevin Sumner was elected to the position of Treasurer of the Board of Governors.
- The Board of Governors approved the extension of Dr. Linda Ross's term as Acting Dean, Faculty of Health Studies, to June 2025.
- The Board approved the appointment of Dr. Christophe LeMoine as Acting Dean, Faculty of Science for a period of one year, beginning January 1, 2023 while Dr. Bernadette Ardelli is on leave.

## 3.4.8. Reports from the Members of Deans' Council (Dr. Docherty will call on these individuals for reports)

#### Arts - Senator Spence

- The Faculty of Arts is about to begin interviews for the Director of Rural Development with the hope of having someone in place by January. The Rural Development Institute is an indispensable part of BU's community outreach and community engagement.
- Currently, there are 124 applications to the Master of Arts (Rural Development) with 90 percent international applicants.
- The vacant position in Visual Arts for an Art History instructor will be filled.

#### Science - Senator Ardelli

- On December 1<sup>st</sup>, Senator Ardelli attended the Citizens Science Building 100<sup>th</sup> Anniversary hosted by the Brandon University Students' Union.
- Dr. Al-Abdillah will begin a one-year position in Computer Science as of January 1st.
- Congratulations to Dr. Gautam Srivastava on receiving an award from the IEEE, which he will accept December 17<sup>th</sup> in Shanghai.
- On behalf of the Faculty of Science, Dr. Ardelli wished everyone peace and happiness for 2023.

- The students are just finishing their practicums and will return to campus in January. Both the faculty and the students are happy to be back on campus this year.
- Cathryn Smith meets monthly with the international graduate students. Senator Duncan attended one of those meetings and was impressed by the way that these students have formed a community and are helping each other.
- Senator Duncan wished everyone a Merry Christmas.

#### Health Studies - Senator Ross

- The Faculty of Health Studies received notice from the College of Registered Nurses of Manitoba (CRNM) that the Nursing program has been approved for an additional five years.
- They have hired for three positions to begin in January.

#### Music - Senator Gatien

- This past weekend, Senator Bach oversaw/hosted a concert competition. A young clarinet performer, Tara Hall, won the competition and will be playing with the university orchestra at some point in the winter term.
- They held an Out of Bounds Lecture that featured a presentation by Remy Renz, "A Literature Based Understanding of Musculoskeletal Playing-Based Disorders in Professional and Pre-Professional Musicians".
- With the return to in-person routines, there were some learning curves. Several students have never had an in-person jury prior to this term. The students and faculty worked together to ensure that stressed out students were looked after.
- Jazz Festival planning is moving forward; the planning team has several musicians
  and teachers who are looking forward to attending and working with students.
  Their target of registering 80 ensembles for their first time hosting the event has
  been reached, and the School is now exploring options for addressing surplus
  interest.
- Sara Hall, voice professor, gave a workshop on posture and mindfulness developing techniques for musicians.
- Gretta Sayers gave a workshop for first- and second-year students on how to manage stresses around exam time – periodizing time, etc.; this was well received by students.
- On January 6<sup>th</sup>, Kerry DuWors will be performing a recital with her long-time collaborative partner.

#### Dean of Students - Senator Gross

- IPC welcomed its new Student Success Officer Rachel Robertson in mid-November. The IPC hosted its annual holiday potluck on December 8<sup>th</sup>. The ventilation work is complete.
- Office of International Activities ran its Destination BU contest and welcomed our IRCC representative for a visit to campus on November 24<sup>th</sup>. The Office will also welcome a new group of students through the Emerging Leaders of the Americas Program in January.
- Student Services sponsored food at the Law Information Session and the Iranian Conflict Information Session.
- Residence Banquet was held on December 2, 2022.

#### CIO - Senator Sucha

- Long Night Against Procrastination was a huge success. Approximately 350-400 students attended, which is comparable to 2019 numbers. Adjustments to the event schedule were well received; feedback has been positive and students have expressed to Library and IPC staff that they would welcome this event again.
- The Library is offering extended hours during the exam period.

- The Library will be conducting interviews for the Indigenous Services Librarian in January.
- ITS is negotiating a new contract with BellMTS for BU's primary link to the Research and Education Network connection in Winnipeg, as the previous 15-year agreement with MB Hydro expires in 2023. This is an important part of the University's network infrastructure, linking BU to the Manitoba National Research and Education Network partner, MRNet, who in turn links BU to the national network, CANARIE. In addition to providing network connectivity to post-secondary institutions, MRNet and CANARIE provide access to federal government funding and programs for cybersecurity services and research computing.

#### University Registrar - Ms. McDaniel

- The 2023-24 admission cycle is well underway:
  - Overall applications received to date are up 38% over the same point last year and the 2<sup>nd</sup> highest they have been since 2016.
  - o 69% of applications received are from international applicants, which is a higher proportion than usual; historically, approximately 60% of applications received have been from international applicants.
  - o Of international applications received, approximately 60% are from Nigeria and approximately 25% are from Ghana.
  - Applications from Indigenous applicants are lower than last year by 7%, so recruitment efforts will continue to focus on this.
- Exams and weather
  - Given the incoming snow and associated weather, an email has been sent to the campus community reminding everyone about the University Examinations policy and highlighting the following points:
    - Students are expected to attend exams and make appropriate provisions to accommodate for weather;
    - Exams are only formally cancelled or rescheduled in the event of University closure;
    - Students with extenuating circumstances must work with their instructors to request a deferred examination.

#### 3.4.9. Report from the Provost & Vice-President (Academic) (Sen. Campbell)

#### Senator Campbell reported on the following:

- The staffing plan process for BUFA is now complete and has been sent out to the Deans.
- Dr. Ardelli has completed her first term as Dean of Science, and he thanked her for the work that she has done. She will now be going on a one-year administrative leave.
- Senator Campbell received a question regarding the review of Follett prior to the end of their current contract. He indicated that the committee has not met as of yet and there are very few alternate options open to the University.

#### 3.4.10. Report from the President (Sen. Docherty)

#### Senator Docherty reported on the following:

- He attended a meeting with the Post-Secondary Presidents Council and the Deputy Minister. The government is moving forward with consultation on tuition and fee policy.
- The Senate bylaws are reviewed every two years, with the next review scheduled to take place in the fall of 2023. Dr. Docherty began a discussion regarding General Faculty Council (GFC) and whether there should be changes to the group. Membership composition and the powers of the council require review. He requested that Senators think about what GFC was intended to be, what it should be, and prepare for further discussions.
